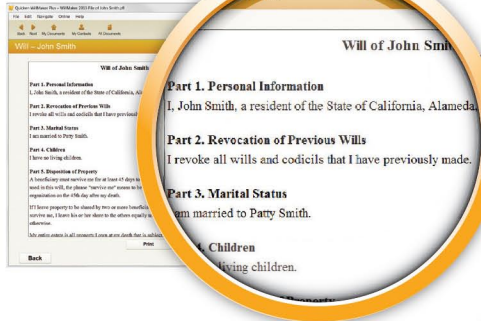

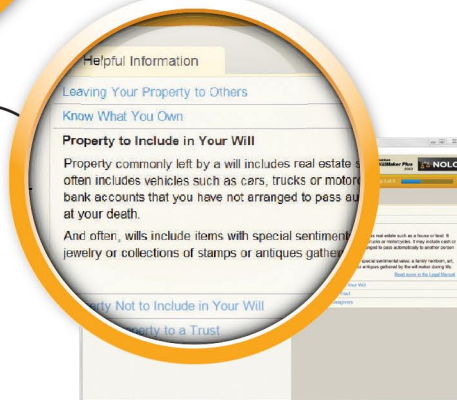

With WillMaker, you can make these key estate planning documents:

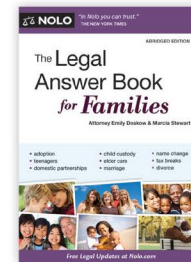
**WILLS** are at the heart of any estate plan. Use your will to:
